With reference to your application dated 01/02/2024 and thereafter on the basis of the scrutiny of the correspondence made with the schools in this regard/school itself, I, Education Officer (Primary), Pune Zilla Parishad, Pune granting temporary recognition to the school viz. GG International School, 339/10(P), Bavdhan. (Bk.), Tal. Mulshi, Dist. Pune run by Goel Ganga Foundation, UDISE Number 27251014735 (Self Financed English Medium C.B.S.E.) for standard 1st to standard 8th for the period of three years from 19th July, 2023 to 31st March, 2025.

The aforementioned recognition is subject to compliance of following terms :-

1. The term of recognition shall not be extended and there will not be any restrictions to get recognition or affiliation after eighth standard.
2. The school will obey the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure One) and Maharashtra Right of Children to Free and Compulsory Education, Rules 2011 (Annexure Two).
3. The school will get enrolled upto minimum 25% of students out of the number of students in first standard from the group of children from nearby weaker section and deprived groups and will impart free and compulsory education till the completion of their primary education, provided further that, the same will also be applicable for the pre-primary standards.
4. In case of children mentioned in Schedule 3, the schools will get reimbursement under Section 12 (2) of the Schools Act.
5. The society/school will not recover any capitation fees and will not compel the student or his parents or guardians to get into any scrutiny process.
6. Admission of any child in the school shall not be rejected on the grounds like want of proof of age, religion, caste or race, place of birth or anything out of these.
7. (One) Any child admitted in the school, should not be kept in the same standard in which he was studying or should not be rusticated from the school till the completion of primary education.
(Two) Any child should not be physically punished or mentally harassed.
(Three) It will not be required for any child to pass examination of any board until he complete his primary education.
(Four) After completion of primary education, the child will be issued with a Certificate under Rule 23.
(Five) Handicapped/Students with special requirements should be admitted as per the provisions of the Act.
(Six) Teachers, having minimum eligibility as ascertained under Section 23(1) of the Act will be appointed. Provided further that, the teachers who do not having the minimum eligibility on the date of commencement of the Act should acquire such minimum eligibility within a term of 5 years.
