Meeting Proceedings:

1. Welcome Address:

The meeting began with a warm welcome to all Executive Committee members by Ms. Dhruvi Bhatia, Principal, GGIS.

2 New Initiatives 2025-26:

Ms. Bharti Bhagwani shared the school's vision and upcoming plans for innovation, wellness, and academics.

Key highlights included:

- Emphasis on innovation-based activities integrated into English and Math
- Encouragement for students to think critically through classroom questioning techniques

- Students from Std. 1 to 8 are introduced to design thinking through school clubs
- A dedicated time slot for innovation, where students will get a free hand to explore topics of their interest

3. Academic Results & Reports:

Three-Year Average Result: A summary of past academic performances was presented.

SAFAL Report: Key observations and areas of improvement were discussed.

Board Exam Highlights: The results of Class X and XII board examinations were shared and appreciated.

4. Review of Suggestions from Last Year's EC Members:

Previous inputs were acknowledged and progress/action taken on them was discussed.

5. Action Plan 2025-26:

The school has planned several academic, co-curricular, and administrative improvements based on stakeholder feedback.

6. Discipline & Food Guidelines:

A sudden classroom check revealed students bringing packed/irritating drinks and packet food.

Ms. Bharti Bhagwani requested EC members to help spread awareness among parents that such items are not allowed.

Emphasis was laid on promoting fresh and homemade food. Students won't be left hungry—school staff ensures they are cared for.

Director reiterated the importance of avoiding non-living/packaged food.

7. Community Service & Social Responsibility:

Community service activities such as Palkhi participation were explained. Certificates will be issued to students for involvement.

NGO tie-ups (e.g., Smile NGO) for waste management and community engagement are in process.

Students may participate in plastic waste drives and adopt-a-school projects.

8. Special Commendation & Support for Board Exemption – Sharvari Somnath Shende

Ms. Dhruvi Bhatia highlighted the exceptional case of Sharvari Somnath Shende, who represented India at the Asia Cup in Bangkok during the scheduled board examination period. Demonstrating the school's commitment to nurturing talent, GGIS extended full support by arranging special examinations upon her return. Despite the demanding schedule of writing consecutive papers, Sharvari displayed remarkable resilience and achieved an impressive score of 73%. The school takes immense pride in her exemplary performance both in academics and on the international sports stage.

9. Innovation Facilities:

The school encourages innovation sessions through structured activities. Students are asked "think and answer" questions to build creativity. A "Thinking Lab" concept has been integrated into classes.

10. Sports Day Announcement:

Sports Day is scheduled on 19th and 20th December 2025 at Bavdhan Sports Ground.

11. Palakhi Circular Clarification:

Parents expressed concern over not receiving a holiday circular for Palakhi.

The concern has been noted, and the school assures that appropriate measures will be taken to ensure timely communication moving forward.

12. Current Affairs Awareness:

A parent suggested starting a daily news-reading session.



Ms. Bharti Bhagwani appreciated the idea. Currently, teachers read news in assembly. Going forward, students will read news to enhance awareness.

13. Session Break & Academic Planning:

A parent suggested a longer break after annual exams.

Ms. Bharti explained that due to the early commencement of board exams from 15th February, classes VIII to X need to begin earlier to ensure timely syllabus completion. However, for classes up to Std. VI, starting the new session in June may be feasible. The proposal will be further reviewed and discussed in upcoming academic planning meetings.

14. Meditation after Yoga:

5-minute daily meditation session post-yoga was suggested.

Ms. Bharti Bhagwani confirmed its inclusion in the schedule.

15. Transport Concerns:

Transport-related issues were raised.

A dedicated Transport Meeting is scheduled for Wednesday. Executive Members & Transport Committee Members are requested to come prepared with specific concerns.

16. Concerns about Student Wellbeing:

A parent raised concerns regarding students' writing speed and the insufficient time allotted for eating fruits during the 0 period.

In response, the school has introduced a dedicated bell to signal the fruit break, ensuring students have adequate time to eat and refresh.

17. CBSE Sports Trials Clarification:

Ms. Bharti Bhagwani clarified that in CBSE sports trials, if a student is selected, Registration process is completed and it may be communicated to the parent as & when required.
